- 1 REALIZE THE SAVINGS**
You can set aside pre-tax money into an account to be reimbursed for eligible dependent childcare expenses. Savings will depend on your tax bracket. For example, if you are taxed at 25% and you enroll for \$5,000 you would save \$1,250 in taxes.

HOW CAN I SUBMIT A CLAIM?

Your Dependent Care FSA can reimburse you for day care expenses provided for your dependent that allow you to work or attend school. The dependent must be a child under the age that lives in your household and is incapable of self-care.

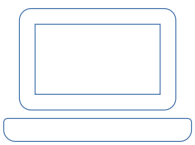
CAN I CHANGE MY ELECTION DURING THE PLAN YEAR?

Yes, you can change your election during the plan year if you have a qualifying status change event. You must

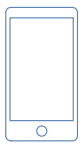
WHAT HAPPENS TO MY DEPENDENT CARE FSA IF I TERMINATE FROM THE COMPANY?
